- The Organizer reserves the right to change the plan of events only if a service provider cannot fulfill the requests of the Client (for example: dancers, speakers, crafter are unable to attend in special circumstances).

PAYMENTS:

- All payments will be made in Canadian dollars, unless otherwise agreed on between the Client and the Organizer and due before the date of the event.

- All payments will include an Administration Fee of 10%.
